Association News

New Board Members

With Board terms completed by Jo Quinter, Jerry French, and Pete Stine, three new members were added this year. Frank Cockrell, Larry Shanks, and Steve Rideout (scribe in training), joined the Board in January.

Frank retired from the Washington Office in September 2004 after 31 years in the Refuge Division and Engineering as Facilities Management Specialist. Throughout, he worked with field stations and Regional Office staff in program planning, budgeting and oversight in areas including BLHP, Refuge Manual, ARMM (Accelerated Refuge Maintenance), Hazardous Waste, and the Service-wide Maintenance Management System (MMS), including 10 years as MMS Team Leader. He was the team leader for 20 facility management inspections at several dozen RF/FH/RES stations and FWS representative on seven DOI Task Forces. He and Elaine live in Beltsville, MD.

Larry began his FWS career in Washington, D.C. in the Office of River Basin Studies. He started the ES office in Annapolis, MD and initiated the Chesapeake Bay restoration program during that time. He then served 10 years as the Assistant Lab Director in Louisiana doing wetlands studies throughout the U.S. before returning to D.C. as budget chief for Ecological Services. In 1986 he became the Chief of Endangered Species and Environmental Contaminants in Denver, serving 8 years. His final 12 years saw him as Refuge Supervisor for Utah, Colorado, Nebraska, and Kansas until his retirement in May 2001. Larry and wife Carleen retired in Monett, MO.

Steve started in the Region 5 Federal Aid Division as the anadromous fish specialist in 1977. In 1979 he became the fourth Connecticut River Anadromous Fish Program Coordinator in Hadley, MA, holding that position for 9 ½ years. He joined the Fish and Wildlife Management Assistance Office in D.C. in 1989 as a staff biologist. During that time he (and Board Member Bob Ruesink) entered the

Service's second Upper Level Management Development Program that included a 9 month assignment with Congressman Silvio Conte's House Appropriations Committee staff. He, with staff, drafted the initial legislation to create the Silvio Conte National Fish and Wildlife Refuge in the Connecticut River watershed. Steve completed his Federal career in 2005 as Director of the Silvio Conte Anadromous Fish Research lab in Turners Falls, MA, overseeing research on migratory fish and fish passage issues.

Board Activities

The Board was proud to provide funding for logistical support to the family of former Director Sam Hamilton who died this past spring. Retirees who attended the October 2009 Reunion Banquet in Kennebunkport, Maine, both appreciated and enjoyed Sam's briefing to the gathering. Board Members Barb Ritter and Frank Cockrell and his wife, Elaine, attended the Celebration of Sam's life on April 9, 2010, and Barb passed on the following to the Board:

Frank and Elaine Cockrell and I were able to attend the very touching memorial service at Main Interior today.

First things first, I have it from an extremely reliable source (Colleen Holland) that the Hamilton family really appreciated the limo service ... the report was that the driver was on time, courteous...almost family. I was struck by the realization that our Association helped with Sam's welcome reception for employees and with his untimely farewell.

As expected, lots of familiar faces were there to celebrate Sam's life. A couple of comments really moved me. Dan Ashe remarked that forty some days ago four friends went to the top of a mountain in Colorado ... and only three came back. So poignant! John Frampton described how Sam had been the right person at the right time to lead the Service and that God must have faced an environmental catastrophe that He had called on Sam to solve.

The ceremony started with the eagle "Challenger" flying from the podium at the front of the auditorium to the back. Both Secretary and the Assistant Secretary for Fish and Wildlife and Parks made remarks (although the Secretary was caught by one of the elemental rules of public appearances ... never work with dogs or children.) Secretary Salazar brought Sam's grandson Davis to the stage with him. The entire ceremony was telecast to Interior offices nationwide and there were several large screen TVs throughout the auditorium, so we all got to watch young Davis as he fiddled with his suit coat, hung off the edge of the podium, and generally fidgeted like any young kid.

Jamie Clark, Corky Pugh (of the Alabama Division of Wildlife and Freshwater Fisheries) and "Rock" Salt(!) (Principle Deputy Assistant Secretary of the Army - Civil Works) all spoke of Sam as a family man, a hunter and fisherman, a leader, and a friend.

The family accepted various awards, including a 30-year service award and the Meritorious Service Award from the Department.

Deputy Director Dan Ashe sent the attached letter to Denny expressing the Service's appreciation for our support to Sam's family.

Other Project Support

In the last issue of the Retiree Newsletter, retirees were asked to write the Citizen's Stamp Advisory Committee in support of a Bob Hines commemorative postage stamp on the occasion of his Centennial year in 2012. This had arisen largely because of his professional stature as a renowned wildlife artist and his contributions to philately. The Association Board sent a letter to the US Postal Service expressing support for such a stamp. We received a response letter in May saying...in summary ... after careful deliberation, the Stamp Advisory Committee decided not to recommend a Bob Hines stamp. They went on to say they have a vast number of recommendations annually, and only a limited number are chosen each year. The Retirees Association is hoping the Service will be able to recognize, in one or more ways, the 100th birthday of Bob Hines in some way. He was the Service's sole wildlife artist for 32 years, until his retirement in 1983. He was born in 1912 and died in 1994. He began his career with the Ohio Division of Wildlife and Conservation, and moved to Washington, D.C. in 1948, 2 years after his redhead duck was the winning design for the 1946 Federal Duck Stamp. He coordinated the Duck Stamp judging event every year until his retirement. His 1957 wildlife conservation postage stamp of the whooping crane was judged one of the best stamp designs in the world that year.

Passing of Colleagues

Jim Hart, former employee at the Natchitoches National Fish Hatchery (LA), passed away June 10, 2010, after a long bout with lung cancer. He is survived by his wife of 49 years, Norma, and two sons, Charles and David. Jim began his career with the US Fish and Wildlife Service in 1960 at Lyman NFH, AL, and later served at Marion NFH, AL; Cohutta NFH, GA; and Natchitoches NFH, LA, where he retired in 1989.

Glenn Bennett Sekavec, 66, passed away on May 22, 2010. Glenn began his professional career with the Fish and Wildlife Service Bureau of Commercial Fisheries in 1967 (which became the National Marine Fisheries Service in the National Oceanic and Atmospheric Administration in 1972). He worked at the Beaufort, NC and Galveston, TX marine laboratories. In 1975, he joined the Fish and Wildlife Service, Division of Ecological Services (ES) at the Galveston ES Field Office and in 1977 moved to the Regional Office (ES) in Albuquerque. In 1979, he became a Resource Management Specialist with the Bureau of Land Management in Socorro, NM and Craig, CO (1983). In 1988, he moved back to Albuquerque, NM with the Department of Interior as the Assistant Regional Environmental Officer and in 1995 became the Regional Environmental Officer. Glenn retired from that position in 2003.

Joseph Wendell Kathrein, a longtime Albuquerque resident, passed away June 11, 2010. He was born December 28, 1919 in Glendive, MT. He retired from the US Fish and Wildlife Service as a fisheries biologist in 1982. Joe served in both the Washington, D.C. and Albuquerque Offices.

Keith Miller was born December 6, 1926, in Mescalero, New Mexico. He served in the U.S. Army during World War II. He was married to Rosaline Dolan on September 2, 1950. Keith worked at the Holloman Air Force Base and at the Mescalero Fish Hatchery for 37 years. Following his retirement from the Fish and Wildlife Service he was elected vice president of the Mescalero Apache Tribe, a position he held for 20 years. Keith passed away on June 24, 2010. He is survived by his wife Rosaline.

Ned Peabody passed away on May 30, 2010. He had suffered from Alzheimer's disease for the last few years. Ned is survived by his wife Anne, his son Mark, daughter Monica, granddaughter Maxine, and grandson Paris. Ned's first assignment was as assistant manager at Tamarac NWR. His career then took him to Lost Wood NWR, Valentine NWR, Bear River NWR, the Pierre Area Office in SD, and finally the Denver, CO, Regional Office. He retired from the Service in 1990 and moved to Eckert, CO. In 1990 he moved to Roseburg, OR, where he lived out the rest of his retirement He was an active skier and tennis player throughout retirement.

Willie J. Parker passed away May 11, 2010. He dedicated his entire life to the protection of our wildlife resources from State Officer to Game Management Agent to Agent in Charge of Maryland, to Special Agent in Charge under the reorganization of the Law Enforcement Division in 1973. Willie had one goal in his career: catch those who would exploit our wildlife resources and he did his job extremely well. Upon retirement he wrote one of the first books on his job "Halt! I'm a Federal Game Warden," excellent essay on just what our Law Enforcement Officers did.

Walter "Perry" White passed away May 16, 2010 He and Willie J. Parker were Game Wardens with the TN Game and Fish in the late 1940s forties and they both ended their wildlife careers with U. S. Fish and Wildlife Service Law Enforcement. Perry came to the Service as an undercover operative. He later served in several positions, including Senior Resident Agent in Louisiana. Most recently, Perry attended the early May Retired Agents "Get Together" in Pigeon Forge, Tennessee, so he was able to visit with many of his old buddies one more time.

Paul Cole passed away on March 18, 2010. He was a Game Management Agent in Florida. He and Fred Williams were among the oldest retired LE Agents.

Fred Williams died on April 1, 2010. Fred came from Tennessee working his way up to Regional Supervisor in the southeast Region. He also spent time in the Washington office. He retired in 1976.

Kenneth A. Ystesund, 88, passed away on July 12, 2010. He was born in Thief River Falls, MN on June 9, 1922, and was a resident of Albuquerque since 1970. Ken was a U.S. Army veteran of WWII and the Korean Conflict, and retired from the U.S. Fish and Wildlife Service. He was an avid sportsman, hunter, fisherman, and storyteller. He will be greatly missed by his friends and family for his warm sense of humor and love of the outdoors.

LOST SOULS

For any number of reasons, the Fish & Wildlife Service Retirees Association has lost e-mail contact with the following retirees. The Retiree Association wishes to be able to contact you in a timely manner to provide news updates and make limited requests. Attempts to contact you has resulted in bounced e-mails with reasons given no such address, mail box full, sender denied, etc. Except for an occasional message, the technical part is that batch e-mail messaging is sent via the FWS Retirees Association list server, a commercial business. The Retiree Association is in the process of updating its address directory of 2600 FWS retirees [we count over 1525 with e-mail] and want to provide your current e-mail address to this system. This will allow you to receive occasional e-mail about activities and events of interest to FWS retirees. For you folks with spam screening or spam blocking software, your system should be set to allow receipt of future messages from postmaster@fwsretirees.org There is an explicit obligation on our part -- the address list is secure and goes nowhere else; it is used internally to provide you information of interest about happenings of the Service, the passing of former colleagues, to help you locate addresses of colleagues you have lost contact with, etc. Also, if you do not want your name on neither the e-mail nor snail mail address list, just let us know and it is off.

If your name is on this list, it means recent attempts to contact you by e-mail have failed. If you recently acquired e-mail or have changed your e-mail provider address and wish to receive occasional e-mail from the Retiree Association, please let us know your current e-mail address with a quick note to the official Retiree Association e-mail address. Now would also be a good time to make any name corrections and add spouses or significant others.
